Declares:

that the ship's compressed air whistle, DHR H400 Maritone, manufactured by Metaalwarenfabriek Den Haan Rotterdam B.V., the Netherlands, has been approved for use on board of sea-going vessels up to 75 metres in length, to which the Netherlands Shipping Act is applicable.

Conditions:

- 1. This certificate is only valid in combination with a valid "Recognition for BV Mode II Scheme;"
- 2. The whistle shall be installed in accordance with the manufacturer's instructions and each installation shall be accompanied by sufficient documentation such as Operator and Installation Manual(s);

 installation submitted for type testing.
